Due to the initiatives put in place by Māori providers, Aotearoa was able to increase the numbers of whānau double vaccinated and boosted giving us a chance to enjoy our summer break. Since the arrival of COVID-19 in March 2020, Wellington Tenths Trust has been a vocal supporter of the vaccination programme and will continue to advocate for our whānau to protect our whakapapa.

As predicted early this year, we are now feeling the effects of Omicron in our community. This is having a major impact on Māori and Pacific health outcomes and affecting many of our whānau across Aotearoa and beyond.

Trustees have supported and put in place Business Continuity Plans that are reviewed frequently to give us assurance and protection of our assets.

Te Raukura, Te Wharewaka o Pōneke Function and Conference Centre has born the brunt of the omicron wave with Wellingtonians working from home, and compounded by the protest and occupation that lasted some 23 days. Despite these challenges Trustees are cautiously optimistic that 2022 will be another positive year. We welcome the news our borders will open from 13 April to manuhiri from Australia and the rest of the world from 1 May.

On behalf of Trustees and myself we look forward to sharing news and details about our Annual General Meeting in the next newsletter.

Kia ora e te whānau kua tae mai nei ki te kōrero ki Ngā Tekau o Papaioea.

It is time to look forward with hope and positive energy in 2022. Despite all the ups and downs of Covid-19 in its many guises, the Trust has kept to its purpose with strength.

From reaching out to you all via the Internet on a large Zui (new word for Zoom hui) to having our next Annual General Meeting and enjoying the whanaungatanga our AGM generates. We have managed the governance of the Trust mostly online so have missed our kanohi ki te kanohi hui to set our course. We do expect we will meet in Palmerston North the first Saturday in September so we can enjoy time together. We were able to have our strategic planning hui in Palmerston North over two days in February this year and we were very excited to see each other and to undertake site visits.

As a result of the strategic planning hui, we were able to walk throughout our new developments and visit the land we have changed from red to green. In other words, we have managed to remove the leasehold on five properties and freehold our land. We will be seeking your support to bring two more residential properties into the Metlifecare orbit. This will be the focus at the AGM. The freeholding gives us future opportunities next to Palmy 31 our student hostel. Trustees are always mindful of the future growth that our young people will have.

As well as viewing those land parcels we went on site at the new retail development on Rangitikei Street, being three large retail shops next door to Tikei Mall. As with all construction in this time there has been many matters to consider including COVID-19, lack of building materials and lack of staff due to isolating or recovery. Despite that we are mostly sticking to the timetable, but it requires constant vigilance. This also applies to the new Metlifecare build that is also progressing well.

Thank you to Vicki and her team who have kept the Hikoikoi and Te Raukura space functioning. We have entered the audit phase which will continue for a few months as we now prepare for our AGM.

We have been able to support whānau in various ways although often through creative ways of engagement. The resilience of our whānau getting vaccinated and keeping well, isolated, and masked up we will come through stronger and learning much.

We are delighted to see Matthew Reweti son of our trustee Ann has put his hand up to stand in the Wellington City Council elections. We want you all to get behind Matthew, so we have a Te Ātiawa Councillor at the table.

Finally, it is with great sadness to farewell Mark Te One from our Board. Mark deserved a well-earned rest as he has served us all with aroha and manaaki over 35 years of service to this Trust. We wish him well and I still call him for the benefit of his advice and wisdom. He is enjoying looking after his mokopuna with wife Sarah.

Ngā mihi o te wā ki a koutou te whānau o Ngā Tekau o Pōneke. Tēnā tātou. He uri ahau nō te maunga Taranaki. Ko Te Āti Awa me Taranaki e ngā iwi. I am a descendant of Hemi Parae and Tawhirikura Karopihia of Te Aro Pā. My father, the late Dr. Leo Buchanan, was a beneficial owner and longstanding Director of Village at the Park. 


Update on Wellington Tenths Trust Property Developments

Update on Palmerston North Māori Reserve Trust Property Developments

Our Trust remains in a strong position and we look forward to sharing the results to 31 March 2022 at our Annual General Meeting 2022. We are excited to share with you our developments at Rangitikei St and Metlifecare on the following page.



Palmerston North Māori Reserve Trust 152-166 Rangitikei Street

This shopping precinct project is proceeding well and on track for completion expected in June 2022. Tenants have been secured with a good mix providing an estimated return of 8% on the development and 6.2% on the land and building.

It was great to see a good area of foundations poured and parts of the structure starting to take shape during our recent site visit with Trustees and staff.



Palmerston North Māori Reserve Trust Metlifecare Palmerston North Joint Venture

Trustees visited the site in February and are pleased with the progress to date. The development contract is with Humphries Construction who use local sub-contractors, the main one being Higgins. Development committee meetings are held monthly and have recommenced for 2022 with the project being analysed every step of the way.

The Metlifecare sales and marketing teams are looking at the marketplace and surrounding areas to gauge pricing of villas with an aim to go to the market in the second half of this year. There has been strong interest to date with the villas being sort after.

Development commenced in October 2021 and it is anticipated that completion of Stage 1 (23 villas) will be in March 2023 and stage 2 by the end of 2023.





Te Raukura - Our Taonga

Nā Takiri Cotterill

Te Rōpū Raranga o Manaia has been actively meeting since 2008 under the Ngahuru Charitable Trust mantle at Hīkoikoi, Petone. Even in our earliest days our rōpū have been involved with Te Raukura, Te Wharewaka o Pōneke helping to dress Te Rerenga Kōtare (waka taua) and Te Hononga with te raukura under the guidance of Honiana Love, Morrie Love and other Te Ātiawa whānau.

Te Raukura has become a passion for our weavers, feeling very privileged to learn more deeply of its significance to our people. Once this journey began, our weavers have wanted to increase our knowledge and expertise in sourcing, preparing and using te raukura.

After two years of hui with weavers, Trustees and the Department of Conservation, Te Rōpū Raranga o Manaia are excited to share with our owners our recent success. Ngahuru Charitable Trust has been approved as an entity which may acquire and possess dead protected wildlife for Mātauranga Māori Purposes with our Wildlife Act Authority being approved. It's exciting and wonderful and we are particularly thankful to one of our weavers, Wendy who has led this process on our behalf in her role with the Department of Conservation.

Our rōpū now look forward to

establishing and sharing a simple process for owners and Trust members to utilise this authority, as the purpose of this exercise has been to simplify access.

Just remember whānau if you are thinking, at last I can get started on that Kahu kiwi, no article made incorporating protected dead wildlife can be taken out of the country or sold commercially - nothing that further endangers our precious taonga.



Ngahuru Arrives

Nā Moana Kaio

It has been really rewarding being able to engage whānau and feed the various rōpū who use Hīkoikoi with hua from the māra. We have grown kamokamo, tomato, rīwai, pikopiko Pākeha (asparagus), kumara, otahua (eggplants), rapikama (capsicum), poukena (pumpkin), rōpere (strawberries), rengakura (beetroot), rengamutu (spinach), korare (spinach), rīki (spring onions and leek), rīki koanga (spring onion) and more.

We look forward to ngahuru (autumn). We are very grateful as well to Te Rōpū Raranga o Manaia who have also created windbreaks and kete kai to use in the māra.



Kura Moana

The WETA Digital season of Kura Moana.

Te Raukura, Te Wharewaka o Pōneke continues to be a key focus for Aotearoa NZ Festival bringing to life the stories of Kupe and Te Whanganui a Tara through the vision and creativity of world reknown artist Lisa Reihana. Kura Moana, the art and gift of ocean knowledge, encourages you to think about some of the local histories and stories that relate to Te Whanganui a Tara while rediscovering familiar landmarks.

Kura Moana focuses on Te Moana-nui a-Kiwa, the great ocean, and its role as connector between Aotearoa and across all the Pacific nations. The opening ceremony held at Te Raukura featured Kupe Raiatea – He Karanga where mana whenua and local communities were invited to place a lei (floral garland) to adorn the Trethewey statue in front of Te Raukura. The waiata Aotearoa played in the background composed by respected songwriter Ngatai Huata retelling Kupe's odyssey and the discovery of Aotearoa from the perspective of his wife Kuramarotini.

Who can miss the impressive and colourful inflatable sculpture that tells the kōrero of Kupe's neighbour Muturangi, who sent a monstrous octopus (wheke) to cause chaos for Kupe's village. Kupe chased Te Wheke a Muturangi across Te Moana-nui a-Kiwa (the Pacific Ocean) eventually arriving in Aotearoa.

Te Wheke a Muturangi sits majestically in Whairepo Lagoon and is adorned with graphics derived from Lisa Reihana's digital tukutuku (weaving) patterns. The other installations include:

- Pūrākau AR | City to Sea Bridge
- Te Haerenga The Journey | Te Papa Lagoon
- Te Wheke The Fight | Te Papa Lagoon
- Kanaikani Rangi The Skydancers | Waitangi Park










Te Raukura



Te Raukura is depicted by three feathers representing honour, peace, and goodwill – symbolising the peaceful teachings of the prophets Te Whiti-o-Rongomai and Tohu Kākahi, who lived at the Taranaki village of Parihaka.

The leaders of Te Ātiawa/Taranaki Whānui ki Te Upoko o Te Ika and Ngā Iwi o Taranaki – with the tautoko of the Kīngitanga from Turangawaewae Marae – conducted a dawn ceremony at Pipitea Marae on 28 February to bring a message of peace and unity to the ongoing protest on their tupuna whenua (ancestral lands) in central Wellington.

As ahi kaa of the whenua, their role is to provide protection to people and the environment in their takiwā (tribal area) and Te Kahu o Te Raukura was laid as a cloak of aroha and peace over the Parliament grounds and our surrounding ancestral sites.

On Wednesday 2 March protesters were moved on from Parliament grounds ending a 3-week occupation.

The Labour Party has selected Matthew Reweti among its Council candidates it announced on Monday 14 March. Matthew will stand for the new Māori Ward, - Te Whanganui a Tara.

Matthew Reweti (Te Ātiawa) is the son of Palmerston North Māori Reserve Trust Trustee Ann Reweti and has a fundraising and communications background with organisations such as the World Wildlife Fund and Plunket. He currently provides contract fundraising to the Wellington College Foundation.

"This is the first time a Māori Ward has existed and I want to represent Te Ātiawa at the Council tēpu," says Matthew.
